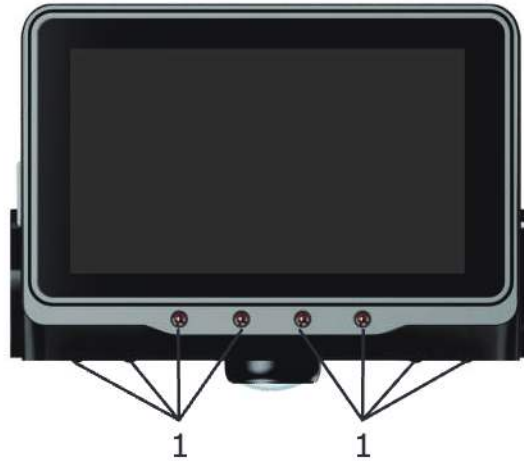

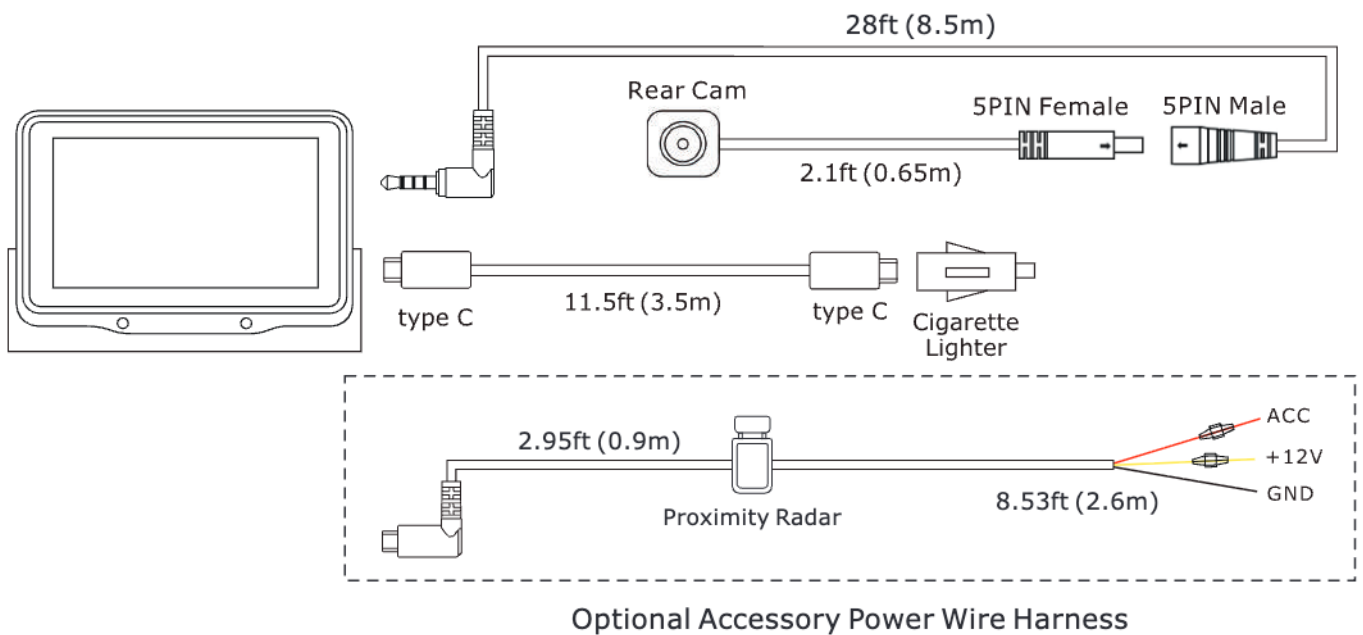

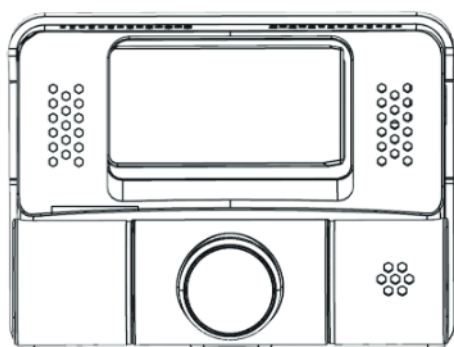

5. Windshield Installation Method

Step 1

Attach the Mounting Wedge to the MiNy360.

- 1) Select the appropriate mounting wedge (27° or 21°) based on the desired installation angle.
- 2) Align the wedge with the sliding slot on the back of the MiNy360.
- 3) Slide the wedge into the slot from right to left until it is fully seated.



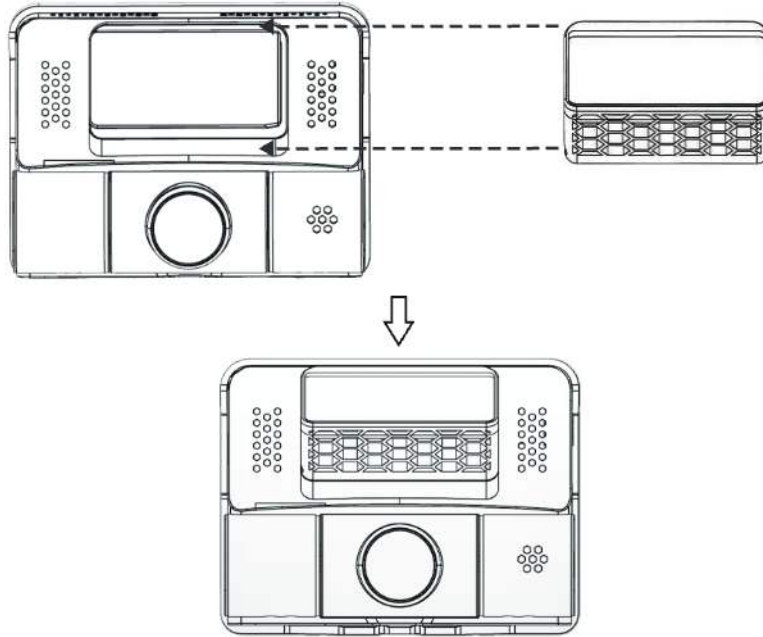

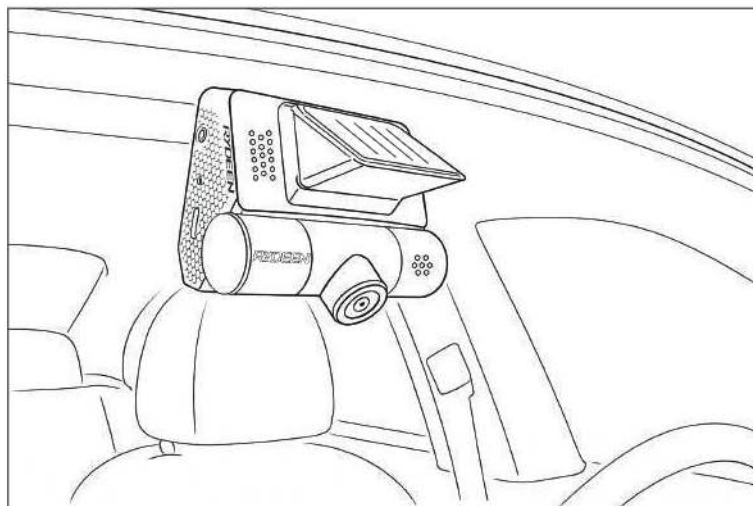




Step 2

Install the MiNy360 to the windshield.

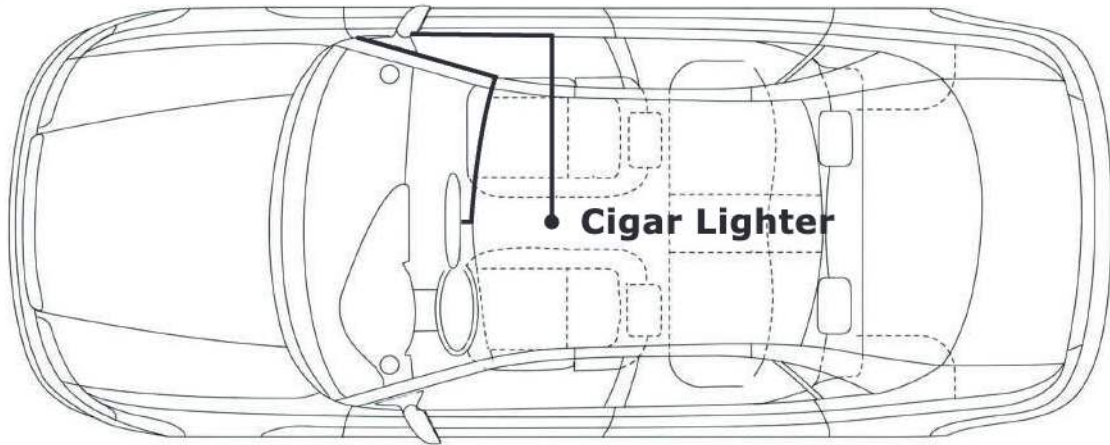
- 1) Clean the selected windshield area thoroughly. Ensure the surface is dry, clean, and free of dust or oil before installation.
- 2) Select a mounting position on the windshield that does not obstruct the driver's forward view, preferably beside the original rearview mirror.
- 3) Apply the electrostatic sticker to the selected area. Attach one edge first, then press evenly to secure the sticker without air bubbles.
- 4) Mount the MiNy360 onto the electrostatic sticker and press firmly to secure.



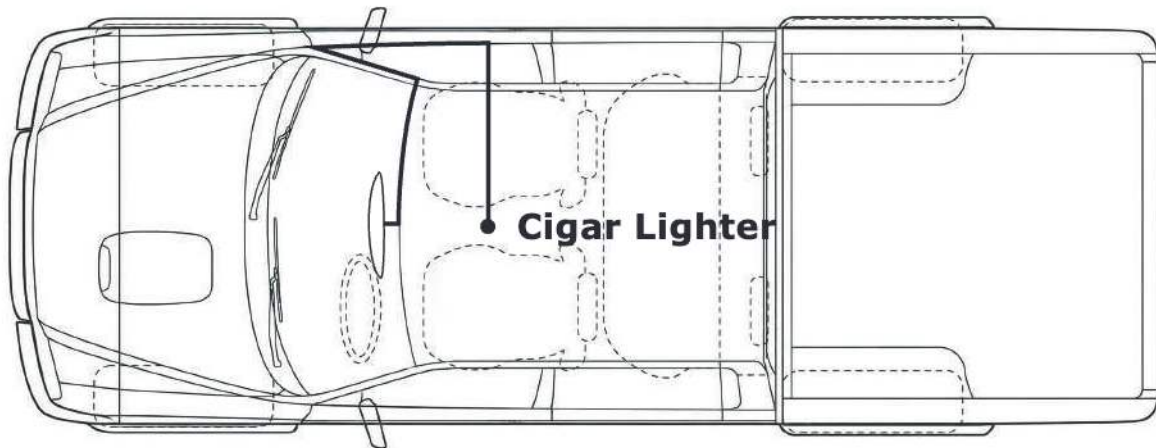

Connect the cigarette lighter or power wire harness and use pry tool to route the wires according to the installation diagram (page 7).

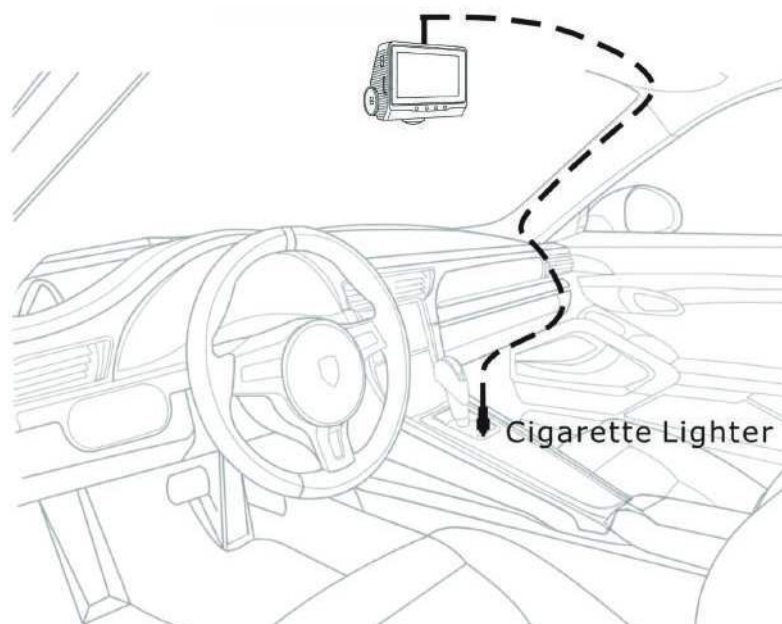

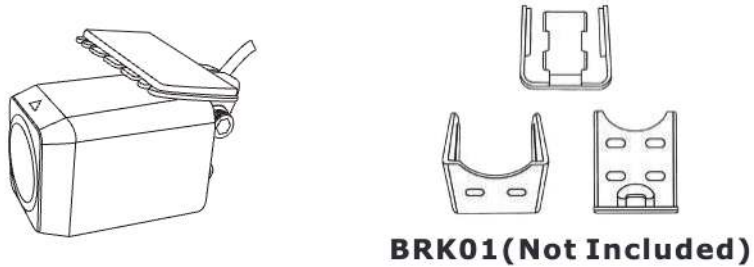

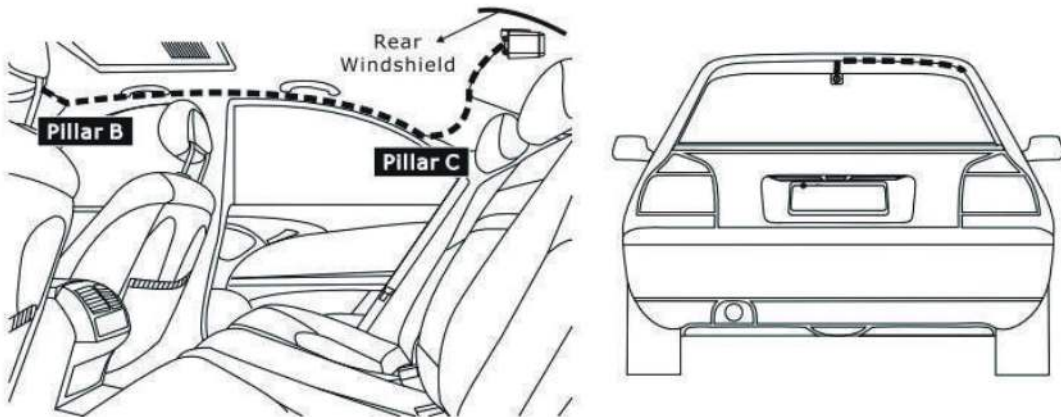


Backup Camera Installation Position Option Diagram

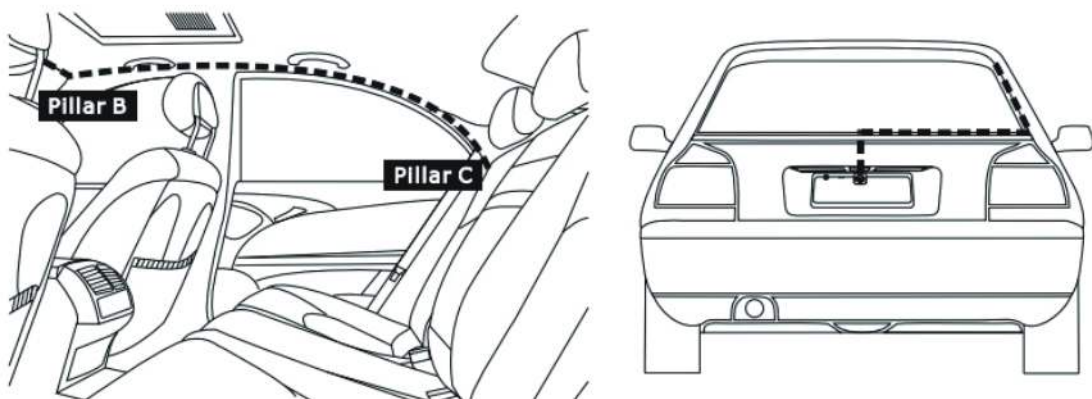

Above license plate mounting location (Exterior mounted)



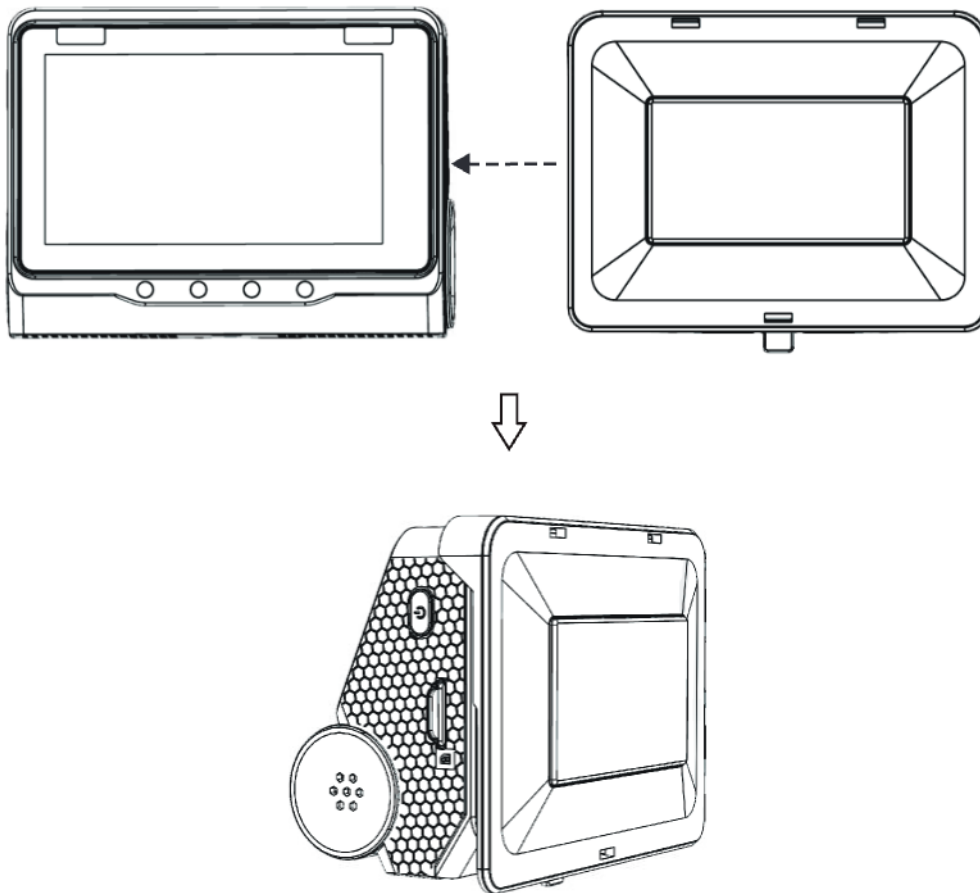

6. Dashboard Installation Method

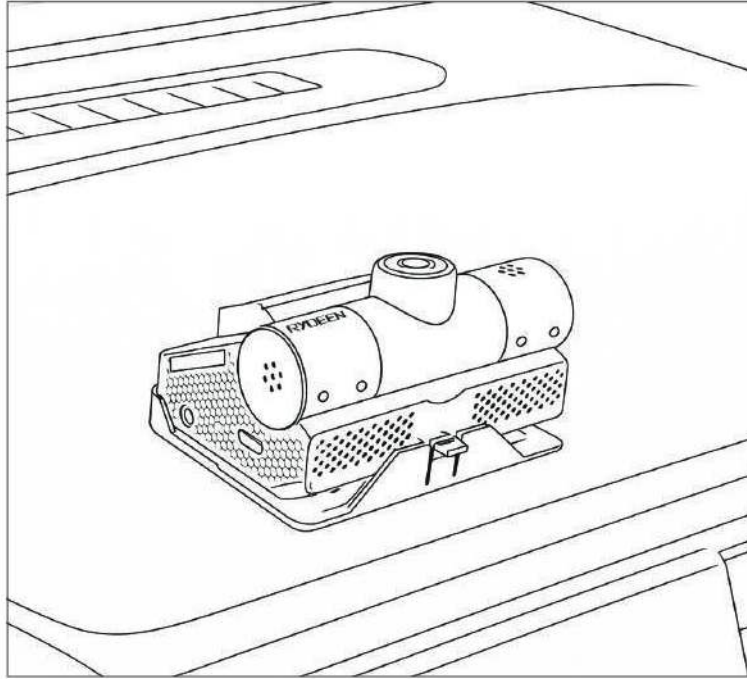
(1) Attach the Dashboard Bracket to the MiNy360.

- 1) Align the dashboard bracket with the mounting interface on the MiNy360.
- 2) Attach the dashboard bracket to the MiNy360 until it is fully seated and securely engaged.



(2) Install the MiNy360 to the dashboard.

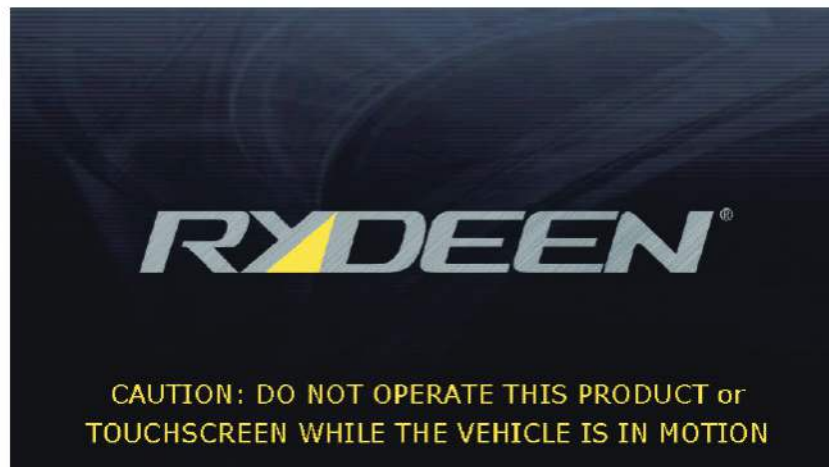
- 1) Select a flat and stable location on the dashboard, preferably near the center, ensuring the display is clearly visible and does not obstruct driving operation.
- 2) The gel adhesive pad is pre-installed. Remove the gel adhesive pad protective film and place the MiNy360 with the attached dashboard bracket onto the selected location.

7.1 Video Recording Icon



The MiNy360 start recording automatically at startup (default). During the dash cam is in normal recording, the blinking red dot will appear in the top center. To stop / start recording, simply press on the icon.



NOTE: Maximum storage (microSD) size of MiNy360 is 256GB, minimum is 16GB. When a new microSD card is used, insert to the slot then go to the setting menu (7.5.2) to format. Bigger the size of memory card, the formatting will take longer time.

7.2 Photo Icon

Select the photo icon to take a snapshot. Images will be saved in “.jpeg” format inside the picture folder.

7.3 File Lock Icon

Press this icon to record SOS files. A small white lock icon will appear on the right side red dot recording indicator.



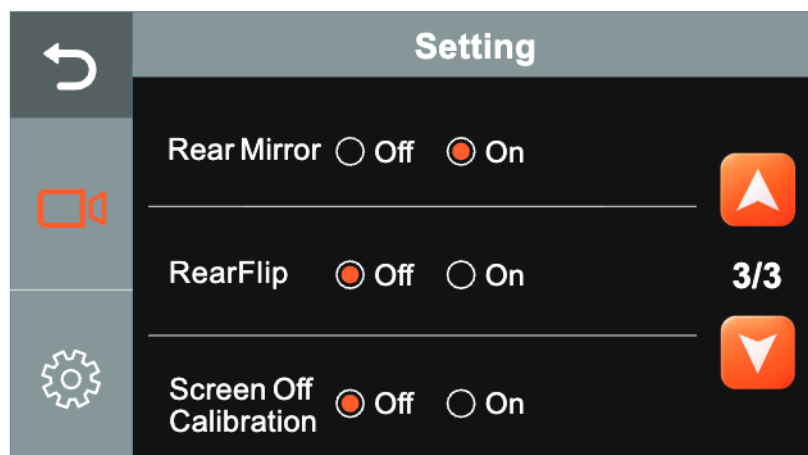
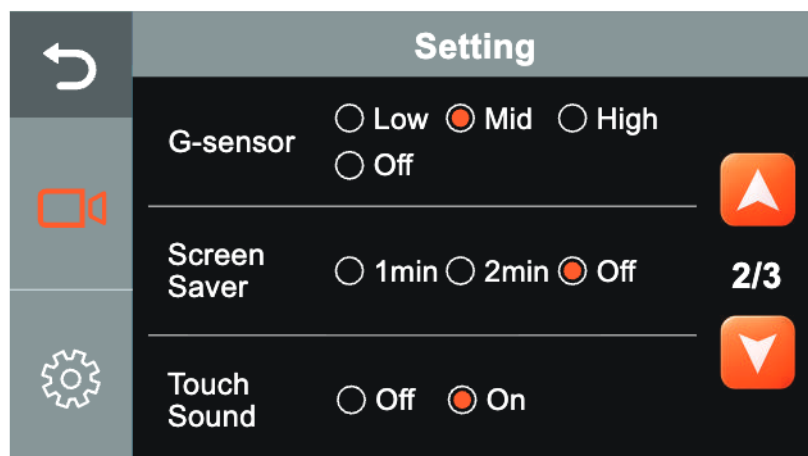
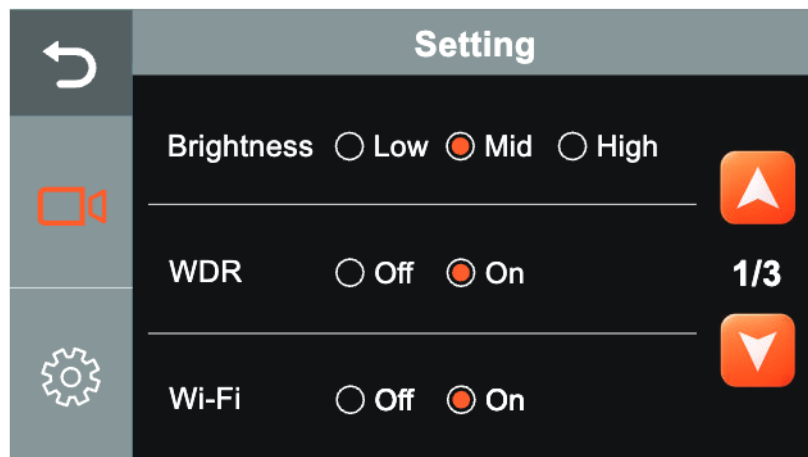
CAUTION: When recording a 30-second SOS video, to protect critical files, touchscreen user operations are disabled, except the snapshot photo shooting.

7.4 Microphone Icon

Tap to turn audio recording on/off. The icon appears red when audio recording is on, and white when off. Changing the mic state will end the current video and start a new recording.

7.5 Setting Icon

7.5.1 Video Settings



Brightness ----- Select the screen brightness level.

WDR ----- Turn on/off Wide Dynamic Range.

Wi-Fi ----- Turn on/off Wi-Fi connection with mobile phone APP.

G-Sensor ----- Select the sensitivity of the G-sensor. The higher the selection, the higher the sensitivity of the G-sensor. Selecting "Off" will disable the G-sensor during normal operation. In sleep mode, G-sensor will be enabled.

Screen Saver ----- Display will turn off automatically after selected time has been reached with no usage. Selecting "Off" will keep display on during vehicle operation.

Touch Sound ----- Turn on/off the system key touch sound.

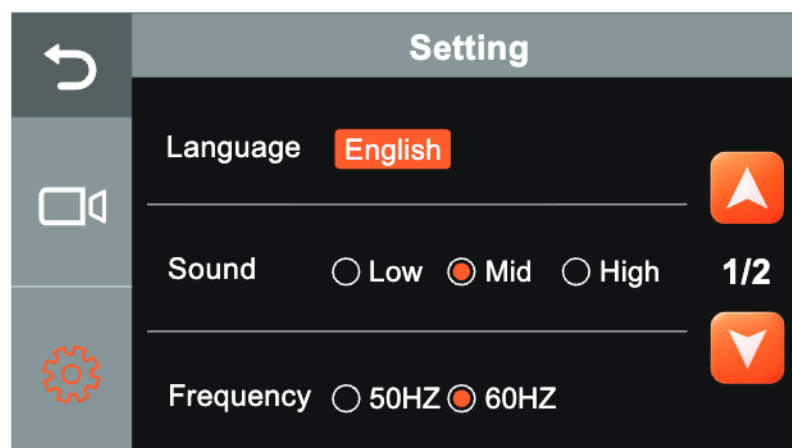
Rear Mirror ----- Switch between standard view (Off) and mirror view (On) for rear image.

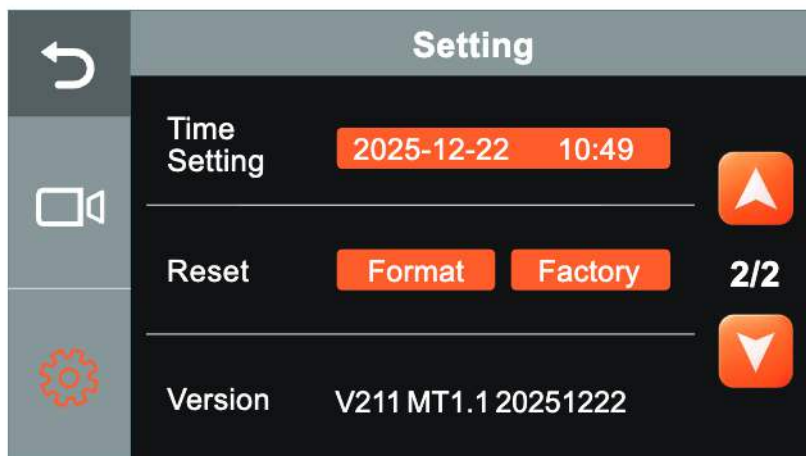
Rear Flip ----- Switch the rear display between standard view (Off) and flipped view (On).

Screen Off Calibration ----- When turned ON, place the dash cam with the screen facing down. The dash cam will memorize this orientation for about 10 seconds. After calibration, the screen will automatically turn off whenever the dash cam is placed at or near the memorized downward angle.

NOTE: Calibration ensures reliable auto screen-off. Repeat if mounting position changes.

7.5.2 General Settings





Language ----- Select the system language, there are four languages (English, French, Spanish, and Japanese)

Sound ----- Adjust volume level.

Frequency ----- Choose the frequency that matches your region's power standard to ensure stable, flicker-free video.

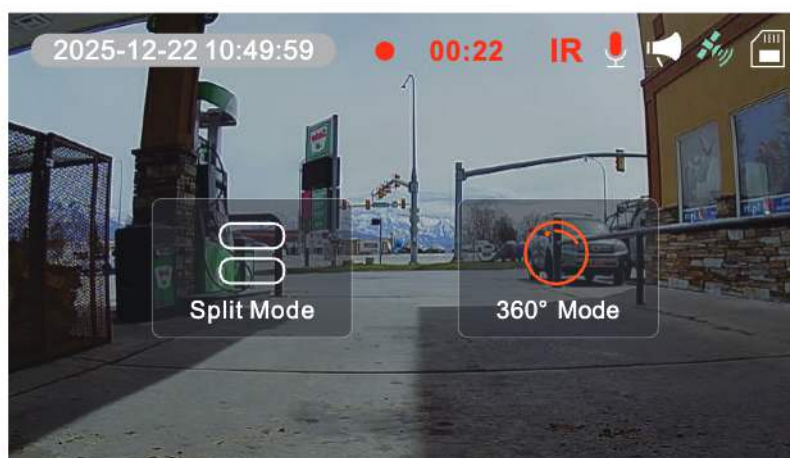
Time Setting ----- Manually set the date and time in the menu.

Format ----- Delete all files in microSD card.

Factory ----- Select this function to reset all settings back to default.

Version ----- Show current software version installed in your device.

7.6 Two Modes for Display



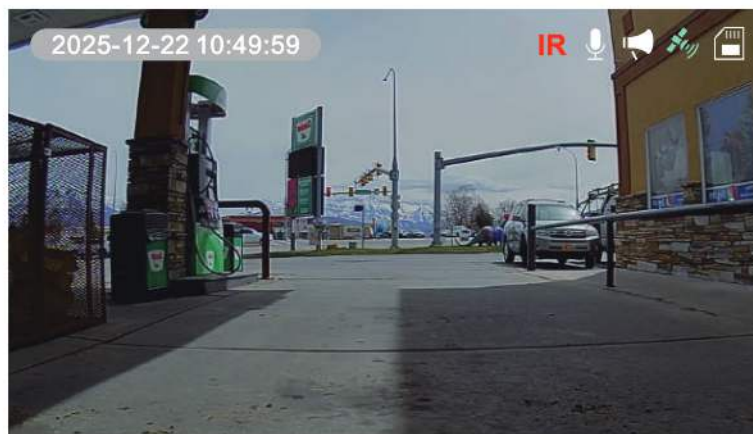
Split Mode

In split mode, you can orientate each individual screen to view a specific perspective of the front of the vehicle and inside view of the vehicle.

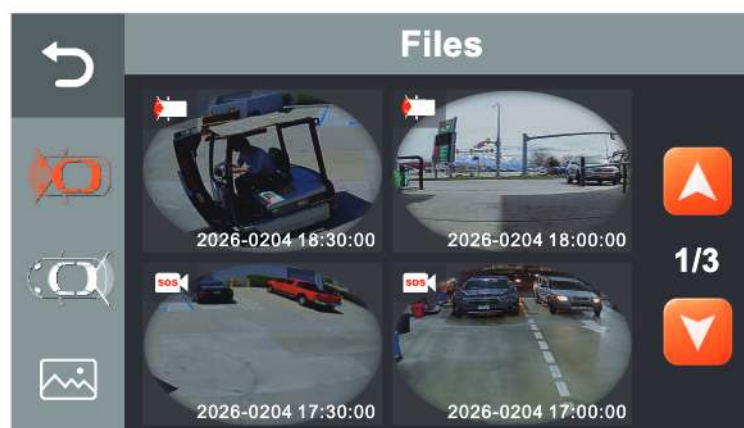



360° Mode

360° mode is the factory default display mode, which can be changed through the screen display mode selection icon. In this mode, you can swipe the screen left and right to view a 360-degree panoramic view of the inside and outside of the vehicle and view a particular perspective.




7.7 Replay Videos and View Photo Icon



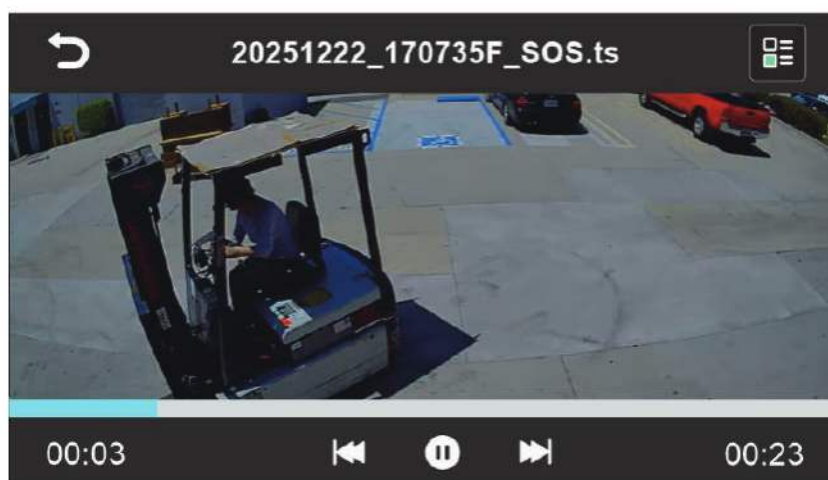
Touch the icon  to enter the files for the front and backup camera recordings and view the snapshots. Recordings and images only viewable when system is not recording.

Select the icon  to view front camera recorded videos.

Select the icon  to view backup camera recorded videos.

Select the icon  to view the photos.

 indicates front camera files,  indicates rear camera files, and  indicates SOS recordings. SOS recordings are saved with an "SOS" tag.

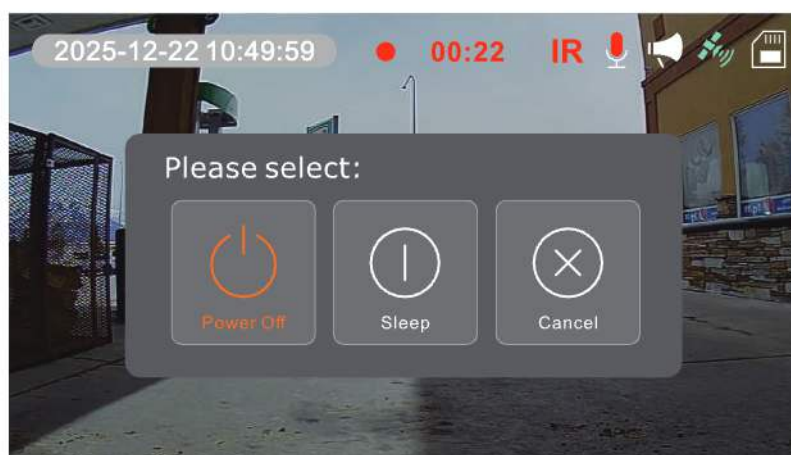


7.8 IR Icon

Tap to manually turn the 8 infrared LEDs on/off. The icon appears red when IR is on, and white when off. IR state must be set manually.

7.9 Power Down

After the vehicle ignition is turned off, a pop-up window will appear on the dashcam screen with three options: Power Off, Sleep, and Cancel.



7.9.1 Power Off

If you choose Power off, the dashcam will turn off completely. In this mode, parking monitoring and the G-sensor are disabled and will not trigger any recording. However, the built-in proximity radar remains active. When the radar detects motion, it will wake up the dashcam, record a 60-second video, and then shut down again to conserve power.

NOTE: To protect your car battery, the radar automatically stops working when the battery voltage drops below 11.8V, ensuring the battery is not drained.

7.9.2 Sleep

Select "Sleep" to enter parking monitoring mode. In this mode, the internal 3-axis G-sensor is active: if a sudden or major collision is detected, the dashcam will record an SOS video as evidence. The proximity radar also works in sleep mode —when motion is detected, the dashcam records a 60-second normal video and then returns to sleep.

NOTE:

- 1) Sleep mode only works when the dashcam is powered via a hardwire kit with constant battery and ACC connections. If you are using a cigarette lighter, the Sleep function will not work. In that case, please do not select Sleep when using a car charger.
- 2) If you select sleep mode and then completely remove power (including from a USB Type-C car charger), the dashcam may repeatedly reboot when power is restored while an SD card is inserted. This is due to a temporary state flag saved in Sleep mode that conflicts with SD card initialization after a full power loss. To fix it, remove the SD card before re-powering, then reinsert and format it after the dashcam starts up. This does not happen with Power off or Cancel mode.

7.9.3 Cancel

If you select Cancel, the pop-up window is dismissed and the dashcam continues working normally, as if the ignition were still on.

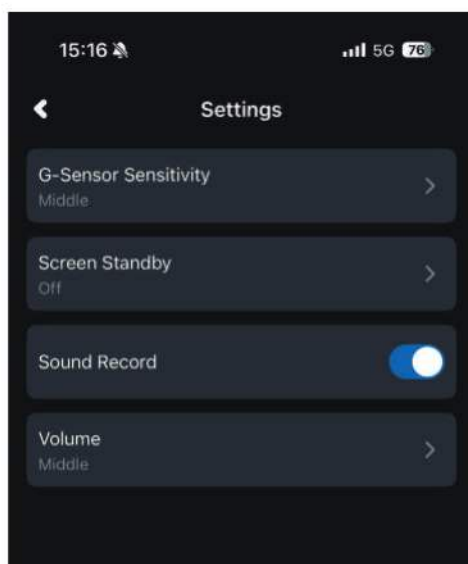
8.3.1 Camera Settings



WDR ----- Turn on/off the Wide Dynamic Range function for front camera

Brightness ----- Adjusts the brightness level of the display to suit ambient light

8.3.2 Record Settings



G-Sensor Sensitivity ----- Adjust the G-sensor sensitivity for the device(Off / High / Medium/ Low)

Screen standby ----- Set the idle time before the screensaver activates (Off / 1 min / 2 min / 3 min)

Sound Record ----- Turn audio recording on or off (ON / OFF)

Volume ----- Adjust the system volume level of operation sounds

Wi-Fi Name ----- The broadcast name of the dash cam's Wi-Fi. Can be changed to your preference.

Wi-Fi password----- The key required to connect to the camera's Wi-Fi. Can be customized. Default Wi-Fi Password: 12345678.

Language ----- Select the dash cam system language (Japanese / French / English / Spanish).

Light Frequency ----- Set to match your local power frequency to prevent light flickering in recordings. Select 50Hz or 60Hz as applicable.

Format microSD Card ----- Select this option to delete all files stored on the microSD card.

Factory Reset ----- Select this option to restore all settings to factory default.

OTA Update ----- Wirelessly upgrade your dash cam's firmware through the app. Ensures your dash cam has the latest features, performance improvements, and bug fixes.

Firmware Version ----- Device Firmware version information.

Note:

- 1) When the mobile app is connected via WiFi, the DVR function can only be controlled through the app. Touchscreen will be turned off during APP connection, it will be turned on and operated after exiting the app for 30 seconds.
- 2) For safety, park in a secure location and engage the parking brake before connecting the mirror app via WiFi, as the rearview monitor and camera functions will be disabled.
- 3) Keep your vehicle's ACC on while using the app to download videos or watch live camera footage on your phone.
- 4) After changing the Wi-Fi name and password, you need to press and hold the power button to restart the device for the new name and password to take effect.

8.4 Privacy Policy

"Rydeen 360" Internet service is provided by Rydeen Mobile Electronics . We regard users' privacy as everyone's basic right. At any time, when you contact us or use "Rydeen 360" related services, we may ask you to provide personal information. We collect, use, store, protect and provide such information in strict accordance with this privacy policy, so as to improve our products, services, content and advertising. You have the right to refuse to provide the personal information we require when necessary; This privacy policy is closely related to the "Rydeen 360" service you use. We strive to express it in easy to understand, concise and concise words, and remind you to pay attention to the important provisions related to your rights and interests in this Privacy Policy in bold. We

hope you can read it carefully and make appropriate choices.

1. What personal information may we collect

1.1 Personal information refers to all kinds of information recorded electronically or in other ways that can identify the identity of a specific natural person or reflect the activities of a specific natural person alone or in combination with other information; When you use the services we provide, we may collect, use and store all kinds of information. In many cases, if you choose not to provide the personal information required below, "Rydeen 360" may not be able to provide you with some or all of the products or services, or achieve the intended effect of the relevant services; At the same time, we may not be able to respond to your problems.

1.2 Personal information that may be collected within the meaning of this privacy policy includes:

1.2.1 Information you provide: including but not limited to your nickname, avatar, gender and mobile phone number; Among them, the mobile phone number belongs to personal sensitive information.

1.2.2 when you use the Rydeen 360 community function or change your personal avatar to take pictures, we will turn on your camera permission with your authorization. The above permissions are sensitive. We only enable them when you need to use the corresponding functions.

1.2.3 We will collect your equipment information and WiFi MAC of dash cam through technical means.

1.2.4 Your information shared by third parties: shared information about you provided by third parties when using our services.

1.2.5 Based on different business scenarios, the Rydeen 360 Intelligent APP has been connected to third-party SDKs. The Rydeen 360 Intelligent APP will only use your personal information for legitimate, legitimate, and necessary purposes, and will take strict security measures to protect your personal information. The required personal information and privacy policies are listed one by one. Click to read more information

1.2.6 Our app provides logoff function, which takes effect in real time without manual audit. After logging off, all the user's data will not be retrieved. Please use the log off function carefully.

1.2.7 To allocate servers nearby and improve the overall use and access speed of users, we will collect your IP addresses.

1.2.8 In order to achieve the service purpose of "PaFiling", the personal information collected by "PaFiling" through technical means is limited to your mobile phone ID, mobile phone MAC, SIM serial number, Android_ID, IMSI, device serial number, basic information of the DASH CAM (we use mobile phone ID, MAC address, SIM serial number, Android_ID, IMSI, device serial number, and recorder ID to distinguish between application software exceptions for problem analysis and feedback) and use time.

1.2.9 Description of MAC sensitive information: We obtain the MAC address of the mobile phone to uniquely distinguish the mobile phone information, so as to collect the APP problem log, better analyze and modify the problem for the specific mobile phone environment, so as to bring better experience to users;

1.2.10 In order to monitor the Rydeen 360 error exceptions and optimize and upgrade the platform, we will collect the application software operation exception information.

1.2.11 We will collect your device information (MAC address), browsing and operation records in order to realize operation fault reporting and analyze and solve the problems you encounter in the process

1.2.12 In order to prevent fraud and protect your information security during use, we will collect your device location information.

1.2.13 Getting the list of installed apps: We get the list of installed apps to enable users to list all the apps that offer sharing functions when they choose to share videos and photos, so as to achieve a better sharing experience.

2. How might we use your personal information

For your personal information collected in the process of providing services to you, we may use it for the following purposes:

2.1 The services we provide to you are divided into basic functions, additional service functions and services provided by third parties. We will explain in detail the personal information collected and used by each service function, the collection method and purpose, and the possible impact of refusing to provide personal information. Service functions include:

2.1.1 Basic functions, including Internet of vehicles interconnection applications.

2.2 Before using the services we provide, you need to create an account in "Rydeen 360" and improve your personal data to ensure the applicability and security of the services we provide you. We will collect your following information in the way you offer:

2.2.1 You need to provide your mobile phone number and register on the "Rydeen 360" page to identify your network membership in "Rydeen 360" and provide you with our services. If you refuse to provide your mobile phone number, we will not be able to create an account and provide services for you.

2.2.2 When you use "Rydeen 360" to connect the recorder function, we will collect the WiFi MAC of your recorder and complete the recorder authorization function service.

2.2.3 You need to provide us with but not limited to nickname, avatar, gender and other information in order to enjoy more services and rights of "Rydeen 360".

2.3 Services that you can use through the "Rydeen 360" service and are supported by a third party. During your use of such services, we will collect (including the information you provide and the information recorded in the system) and necessary personal information, and share them with the third party providing service support with your consent, And indirectly obtain relevant information about your use of the service from a third party. If you refuse us to collect and share such information, you will not be able to use the corresponding third-party services.

3. User rights and responsibilities

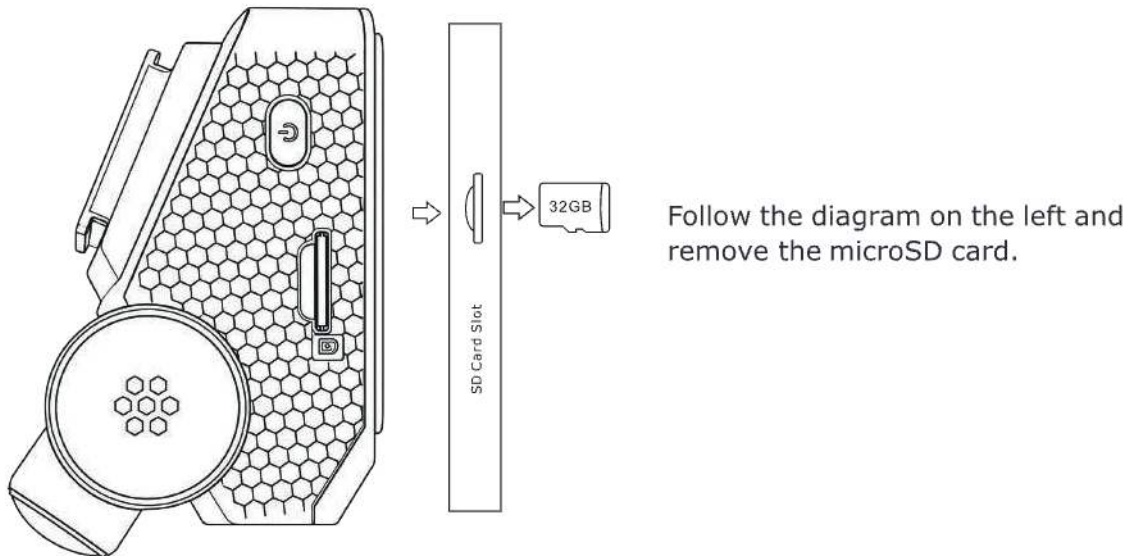

MiNy360 uses Pre-allocating file management to provide you with a safer experience. If you need to play the video on your PC, please check the provided microSD card in the device.

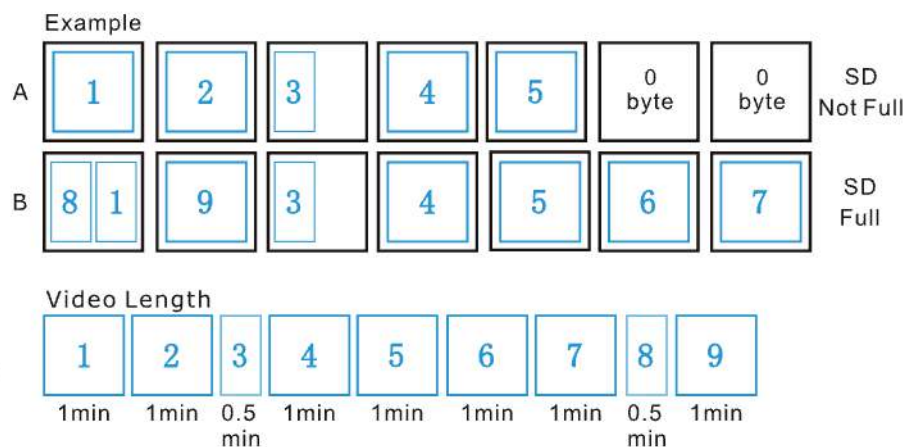
There is a file named "Tombo360Setup" inside of folder "exe", please install and run the software on your PC.



Note: MiNy360 uses Pre-allocating memory for file management. The system will generate 0-byte files in the folder during initialization. When recording videos are generated, the recording videos will occupy the 0-byte files one by one. Please use the provided video player in the microSD card to playback the recorded videos, if you want to view the videos on a PC.

Pre-allocating File Management Instructions

As shown in the example right, the blue squares represent the recorded video files and the black squares represent the pre-allocated storage space. Assuming that the microSD card has only 7 pre-allocated storage spaces and the duration of video "3" and video "8" is half a minute and the other videos are 1 minute.



Case A, when the microSD card is not full, video "1", video "2", video "3", video "4", video "5" will be stored in the pre-allocated storage spaces in sequence. The remaining pre-allocated storage space will show 0-byte files.

Case B, when the microSD card is full. Since the storage device only has 7 the pre-allocated storage spaces, video "8" will occupy a portion of video "1" and video "9" will completely overwrite video "2".

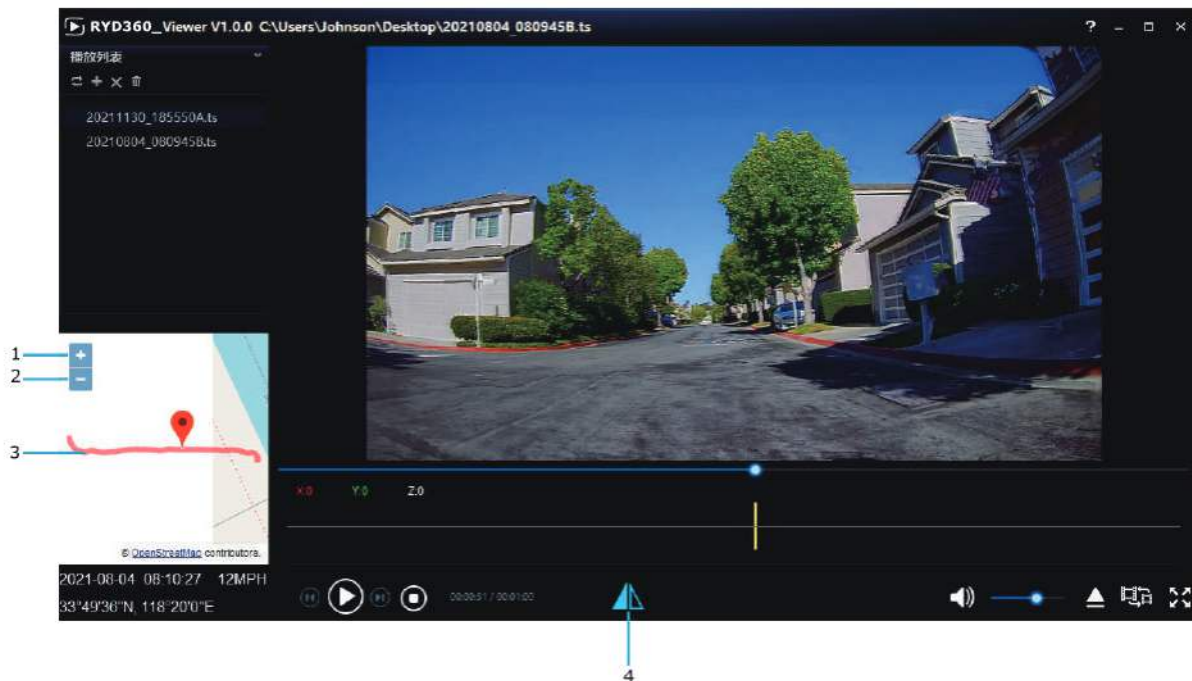

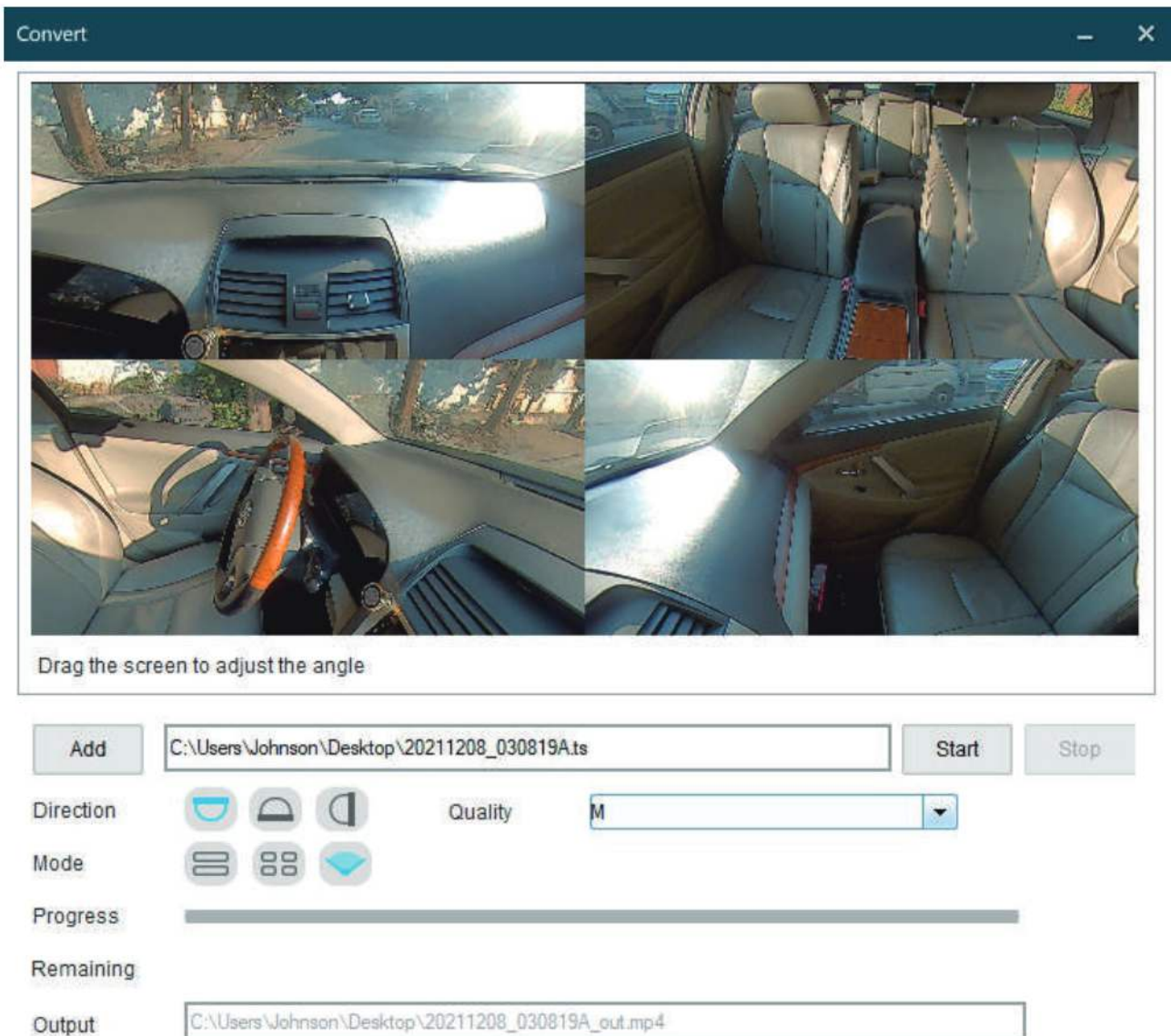
